**2. Terms and Conditions:**

- a. The period of meeting including transit will be treated as on duty;
- b. They will draw their usual pay and allowances from Bangladesh in local currency;
- c. Bangladesh authority provided local hospitality for the Srilankan delegation earlier in 4<sup>th</sup> meeting which was held in Dhaka. It is expected that Srilankan authority will extend local hospitality as per customs. In that case air fare, daily allowance along with other allowances may be borne by the respective Ministry/Division /Organization of the delegation as per existing rules and practices;
- d. They will leave Dhaka for Colombo on 07 November, 2016 or nearest possible date and they (except serial no. 2) leave Colombo for Dhaka on 10 November, 2016 or nearest possible date;
- e. After attending the meeting Mr. Abul Mansur Md. Faizullah, ndc, Additional Secretary, ERD will attend the Seminar on ICT International Finance Day during 09-15 November 2016 in Japan. All expenses will be borne by the organizer in this regard. Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer. After attending the Seminar, he will leave Japan for Dhaka on 15 November 2016 or nearest possible date;
