2. **Terms and Conditions:**

 - All expenses regarding this visit will be borne by Agency Francaise De Developpement (AFD). Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer;
 - They will leave Dhaka for Paris on 15 November, 2016 or nearest possible date and leave Paris for Dhaka on 19 November, 2016 or nearest possible date;
 - They will not be allowed to stay abroad more than the approved period;
 - They will have to submit a report to this office within 15 days after their return from abroad.
3. This order is issued with the approval of the competent authority.


