 - d. They will leave Dhaka for Beijing on 19 March, 2018 or nearest possible date, and leave Beijing for Dhaka on 10 April, 2018 or nearest possible date;
 - e. They will have to submit a report to this office within 15 days after their return from abroad;
 - f. They will not be allowed to stay abroad more than the approved period.


