 - d. He will leave Dhaka for Bonn, Germany on 18 March, 2018 or nearest possible date and leave Bonn, Germany for Dhaka on 21 March, 2018 or nearest possible date;
 - e. He will have to submit a report to this office within 15 days after his return from abroad;
 - f. He will not be allowed to stay abroad more than the approved period.
2. This order is issued with the approval of the competent authority.


