2. **Terms and Conditions:**

- c. All expenses regarding this visit will be borne by United Nations office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States (UN-OHRLLS). Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer;
- d. They will leave Dhaka for Vanuatu via Singapore and Australia on 25 October, 2017 or nearest possible date and leave Vanuatu for Dhaka via Singapore and Australia on 28 October, 2017 or nearest possible date;
- e. They will have to submit a report to the concerned authority within 15 days after their return from abroad.
- f. They will not be allowed to stay abroad more than the approved period.
