 - c) All expenses regarding this visit will be borne by the International Centre for Climate Change and Development (ICCCAD). Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer;
 - d) They will leave Dhaka for India on 07 October, 2017 or nearest possible date and leave India for Dhaka on 15 October, 2017 or nearest possible date;
 - e) They will have to submit a report to the concerned authority within 15 days after their return from abroad;
 - f) They will not be allowed to stay abroad more than the approved period.
3. This order is issued with the approval of the competent authority.


