

The undersigned is directed to convey the Government's approval to Ms.Roksana Khan, Deputy Secretary, Economic Relations Division (ERD) to attend the "Clean Technology Fund (CTF) Trust Fund Meeting and Pilot Program for Climate Resilience (PPCR) Sub-Committee Meeting organized by Climate Investment Funds (CIF) of World Bank during 11-15 December, 2017 to be held in Washington DC, USA under following terms and conditions:

- a. The period of meeting including transit will be treated as on duty;
 - b. She will draw her usual pay and allowances from Bangladesh in local currency;
 - c. All expenses regarding this visit will be borne by the organizer Climate Investment Funds (CIF). Therefore, this will not involve any additional expenses from the Bangladesh Government exchequer;
 - d. She will leave Dhaka for Washington on 10 December, 2017 or nearest possible date and leave Washington for Dhaka on 16 December, 2017 or nearest possible date;
 - e. She will have to submit a report to this office within 15 days after her return from abroad;
 - f. She will not be allowed to stay abroad more than the approved period.
