- They will leave Dhaka for Swizerland on 12 July, 2023 or nearest possible date and leave Switzerland for Dhaka on 15 July, 2023 or nearest possible date;
- They will have to submit a report to this office within 15 days after their return from abroad;
- They will not be allowed to stay abroad more than the approved period.
