- e. All expenses of Ms. Rokeya Khaton, Joint Secretary (serial no. 4) regarding this visit will be borne from the budget of Economic Relations Division as per existing rules and regulations;
- f. Ms. Rahima Tasneem Rahman, sister of Ms. Fatima Yasmin will accompany her during this visit. All expenses of her visit will be borne by Ms. Fatima Yasmin.
- g. They (serial no. 2 & 4) will have to submit a report to concerned authority;
