- She will leave Dhaka for London on 19 June, 2022 or nearest possible date and leave London for Dhaka on 25 June, 2022 or nearest possible date;
- She will have to submit a report to this office within 15 days after her return from abroad;
- She will not be allowed to stay abroad more than the approved period.
