d. They will leave Dhaka for Australia on 27 May, 2023 or nearest possible date and leave Australia for Dhaka on 10 June, 2023 or nearest possible date;
e. They will have to submit a report to the concerned office within 15 days after their return from abroad;
f. They will not be allowed to stay abroad more than the approved period.
3. The Government Order memo no.09.00.0000.072.25.001.23-282 dated 27.03.2023 is hereby cancelled.
4. This order is issued with the approval of the Competent Authority.
